Professional Members are dues-paying members, have full voting rights and may hold any office.

General Members - General Member is an individual that is engaged in human resource management but does not meet the requirements for Professional member. General Members are dues-paying members, have full voting rights and may not hold elected office

Associate Members - An Associate Member is an individual that does not meet any of the foregoing categories but has a bona fide interest in human resource management. Associate Members are dues-paying members, have full voting rights and may not hold elected office.

Membership in DallasHR is on an individual basis and is non-transferable.
